ADDITIONAL FEATURES FOR THE NEW ADMIN CENTER

We have continued to bring new features into the new Admin Center, including the following:

- New Super User Admin Role Option
- New Person Search Criteria Option on Invitation Status

New Option for 'Super User' Admin Role


A new Configuration Permission exists for a "Super User" Role. Super User Permission allows a site with multiple levels of an admin role to limit which roles the lower level admin can grant when editing a user account. This will allow sites to prevent those admins from granting access to roles that are higher than their own.

This is turned off by default.



New People Search Criteria Option on Invitation Status

There is now the option to search on 'Person Invitation Status' within the Admin (Beta) Center People Search. This enables a search to be run to easily identify anyone that has accepted, declined, or not yet responded to an invitation to review.



Added Session Proposal Review Fields to the Data Export XML

We have added the ability to include session proposal scoring details in custom reports.

Custom Details for People

Ability to Add Custom Questions on the Person Account Level

It is now possible to add custom questions on person records to be filled out during account creation and on already created accounts. For the later scenario, if the question is configured as required users can be prompted to complete their account information upon login, and will be directed to the newly added question in their profile.


These custom questions can also be configured to be completed by Admins only or to be completed by the users.




Ability to Search on People Details in People Search

The Custom Person Details are available to be included in the search options in the New Admin Center. Simply choose to add your configured Custom Question in the "Select Search Criteria" Section of the People Search, and it will appear below in the search. Please see below example:

People Details Available as Email Tags


People Details are now available as email tags in the system.

Declare My Disclosures


Now users can submit Conflicts of Interest for review within the system. Presenters and hosts may have a conflict of interest that is relevant to a specific activity or presentation that does not apply to all presentations. Presenters can simply log in and declare their conflicts of interest through the Message tab. Hosts will access the disclosures through the same tab (see below).





Presenter View:

Once the presenter or session host has declared the disclosure's relevancy to his/her activities, an email will be triggered to the session host (for presenters) or the session owner (for session hosts) so that the information can be reviewed. Additionally, the session host and session owner will be able to see all of the presenters and whether or not they have submitted their disclosures for review (see below).



Host View:

This is the screen the host will see when reviewing the disclosures for a specific activity to ensure there will not be conflicts of interest with any presentation:





Scholar One Ideas

ScholarOne Ideas is a community-driven ideas portal that allows participants to post their product ideas, comment on the ideas of their peers, and vote to promote or demote ideas. This tool offers clients a direct, transparent, and interactive line into the development process for the product. With the release of v4.11, users will see another great enhancement to the product based entirely on your top Ideas.

Search Criteria for Potential Reviewer Flag

Reports and emails can be generated based on the potential reviewer flag and area of expertise. You can send emails or report on people based on their response (or lack of a response) to the "Do you want to review submissions that are based on your areas of expertise?" question.

Ability to Change Duration of Session without Rescheduling*

In 4.11 we have eliminated the need to reschedule sessions after changing the duration. The system will now automatically adjust the end timing of the session after the duration is updated.

Return Search Results

In admin center search, we have added a "Return" button at the bottom of the page for easier access. This will be available for Abstract, Session, and People searches when running in HTML format.
